## Services Offered

Stepping Forward provides a comprehensive service system that promotes long-term recovery from co-occurring substance abuse and mental health disorders, and improves permanent housing retention. An Individual Treatment Plan is tailored around the unique needs of each participant served. Each participant is encouraged and guided in driving the goals and objectives of his/her treatment plan as he/she progresses through different stages of treatment.

Services are available to Next Step Home and Stone Residents participants in their homes, or Stepping Forward offices located at 179 North Main Street, Fall River, MA.

Services available:

- Outreach and engagement
- Intensive case management
- Housing retention and support services
- Independent living skills
- Motivational interviewing
- Crises care intervention
- Substance abuse and mental health assessments and evaluation
- Psychiatric services including medication management
- Integrated Dual Diagnosis Treatment
- Individual, couples and family counseling
- Group therapy
- Psychosocial rehabilitation
- Assistance obtaining income and entitlements
- Employment readiness education and referral
- Assistance connecting to self-help programs
- Discharge and aftercare planning

## Referral Process

Applicants of Next Step Home and Stone Residents are provided information regarding enrollment into Stepping Forward and if interested, a case manager of Next Step Home or Stone Residence completes the referral to Stepping Forward.
